MEMBERSHIP PROCESS

The process for becoming a Member of SWS is as under;

- 1. The Buyer has to send a mail to <u>solariswelfaresociety@gmail.com</u> expressing interest to become a member with "SWS Membership Interest" in the subject line.
- 2. Following documents have to be attached with the mail;
 - a. Builder Buyer Agreement / Flat Allotment Letter (complete with all Annexures)
 - b. Application Form duly filled in (Annex-I)
 - c. Information about outstanding dues & willingness to join other buyers for completion of project through SWS in Format at Annex-II
 - d. Photo ID of Allottee or Co-allottee seeking Membership
- 3. After the documents are verified by SWS, the Buyer shall be intimated acceptance.
- 4. After such acceptance, the Buyer has to deposit Fees of Rs. 5000 (Rupees five thousand) which includes Rs. 500 towards Membership Fee (one time) and Rs. 4500 towards preparatory & legal expenses in the designated Bank account of SWS.
- 5. SWS will confirm Membership after receipt of requisite fees.
- 6. Only One person can become a member against one flat.
